

The Virtual Basket

The Importance of Our Seventh Tradition During a Pandemic

In March of 2020 COVID 19 was ravaging the world's population. AA Groups in Queens County and throughout the United States adapted by shifting their meetings to virtual platforms. Alcoholics Anonymous members again showed our resiliency in the most trying of circumstances. New members joined and stayed despite all of the challenges that we face.

In these new and challenging times, how can we assure that the program and fellowship that saved our lives is available for both the immediate and distant future? How can we assure that we still have the services that are so vital to AA's survival? The virtual basket is critical to maintaining our infrastructure. While group expenses may be down at this time, other services still move along. Our literature is still produced and distributed, the GSO service desks continue to perform their functions in dealing with hospitals and institutions, incarcerated members, our Trustees need to do their business and the Grapevine still needs our support. Many of these services are still being facilitated at the Area, County, and District Level as well.

The phones are still ringing at our local intergroups. In order that we may be there when anyone, anywhere reaches out; phone bills and rents must be paid. The vital 12th step work that we do has become increasingly challenging. COVID has made navigating the hospital and detox system more difficult, so a greater effort is required to link a sick and suffering alcoholic to a bed.

While some expenses may be down, other expenses have remained the same or gone up. We can remain self-supporting through the virtual basket. Most groups and AA services have set up virtual contribution options such as Venmo or Paypal but I have personally received envelopes of cash contributions from group members not yet comfortable with the virtual exchange of money. While some of us may be struggling to put food on the table, many of us still have the ability to put some dollars in the virtual basket. I want the hand of AA always to be there.
